**Y**ou might be surprised to learn that if you've never given your authorization to add a joint name to your account, DRN cannot allow him/her (whether it be a spouse or roommate) to vote at the annual meeting or make changes to your account. DRN does this to protect your account from any unauthorized changes. By adding a joint name, the primary person is allowing the joint name to add services, inquire about billing, charges, etc.

This is not a Proxy Statement. *Individual members of the cooperative cannot use this form, but members who are organizations such as corporations, companies, partnerships, churches, school districts, political subdivisions, cooperatives, associations, and other organizations can use this form to designate one individual to represent the organizational member for voting purposes. An individual may only represent one entity in addition to the individual being able to vote for themselves.*

Appointment of Voting Representative forms presented the night of the Annual Meeting will not be recognized.
